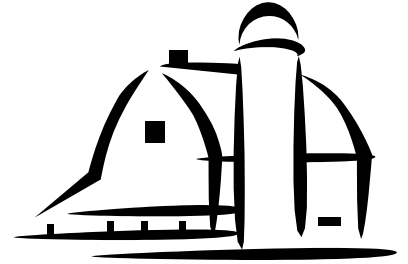

Carver County Barns

The Barns of Carver County and Barn Quilts of Carver County are not the same. As similar as the names sound, they are not the same project. The question of which is which has arisen a number of times in the last year, so I thought it was time to clarify things..

The Barns of Carver County project is owned by Ruth Tremblay. Ruth, a commercial artist, has spent the last few years visiting farms around the county and photographing the barns. She has copyrighted her project. Ruth donates a portion of the proceeds from the sale of her yearly calendar to the Carver County Food Shelf and Mary's Wish. You may donate directly to either nonprofit by making checks out to the organization of your choice.

The Barn Quilts of Carver County was organized and is run by two volunteers, Naomi Russell and Suzanne Thiesfeld. Naomi and Suzanne wrote a Legacy grant for the project through the Minnesota Arts Council, two years ago. The project fiscal agent is the Arts Consortium of Carver County (ACCC). Neither Naomi or Suzanne receive any compensation for their work. Donation for this project are accepted by the ACCC and are tax deductible.

Neither of these projects belong to or are sponsored by the Carver County Historical Society. We have both sold Barns of Carver County calendars and have hosted Barn Quilts of Carver County tours. If you have any further questions please don't hesitate to contact the CCHS.

Date/Time: Sat. April 7, 12-3pm at CCHS

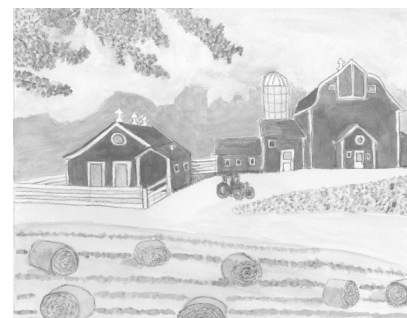
